Lecture	This is a reading course. Students are required to read all assigned required readings, as indicated in the course outline, before coming to the classroom. This means not just skimming the material but reading it carefully and being ready to discuss it. The required readings include specialized research monographs or journal articles. However, please note that in addition to this we may summarize in class the general findings on the topic mentioning other readings, therefore, in case you might want to read them for yourself I am listing the references under optional readings along with further readings on a particular topic. All required readings and most of optional readings (excluding books) will beavailable electronically.
	The assessment consists of two written tests in the middle and at the end of the course. The date and time of the tests will be announced later. Each test will consist of short-answer questions and 1-2 essay-style questions. Exam questions will be based on lecture slides from Lectures and required readings; therefore, in order to pass the tests, it is important to have read all of the required readings and to attend the lectures.
