To achieve a grade 3+ or 3, students should try to participate in class discussion, prepare a satisfactory presentation in class and a satisfactory final essay. Some errors or omissions are acceptable.  A student will fail the course if he/she does not make an effort to read the readings and therefore to participate in class discussion, if s/he does not prepare a multimedia presentation and/or if he/she does not deliver the final essay.
