Goals

Code	Goal
C1	Taking into consideration the number of course hours, the fact that almost all of the students have no knowledge of French, the language requirements of EU institutions relating to the second procedural language (French or German) where future graduates of ELS could work, namely a practice of the language mainly centered on the written comprehension of legal documents, the objectives of the French course are as follows: Allow learners to reach an A2-B1 general language level in written and oral communication. Allow learners to approach, on the basis of the English / French translation, the legal acts of the EU (Treaties, Directives, Regulations; etc ...) with regard to their structure, terminology, language rituals, etc. ... by using their legal knowledge provided in English.
